Mr. Barry McCabe and Mr. Peter Rand, both residents of the Campbell Tract, were present to express their concern about the Board of Supervisors granting a further extension to this project that has not been completed by the developer. Mr. Rand explained the last of the 3 homes was finished 3-1/2 years ago, and there are still outstanding development issues that need to be completed. Mr. McCabe explained he has drainage and runoff over his driveway due to the swale along Smith Road. Mr. Gray concurred that the main outstanding item is the drainage in front of lot 3 that needs to be addressed, and there are some outstanding landscape items.

Mr. Gray explained he spoke with the developer recently who was delayed due to COVID-19 restrictions, and recommended providing them with a six-month extension to complete the project.
