PUBLIC COMMENT

Mr. Stephen Scardetto, 808 Pineville Road, was present to express frustration in the process of trying since 2011 to develop a single-family dwelling on his property. He explained going before the Zoning Hearing Board requesting a variance to allow a shed that he had constructed prior to receiving building permits which ended up being built on a pre-existing pad which was located in the township right-ofway; hence the variance was denied. Mr. Scardetto said he since has relocated the shed and pad beyond the 50-foot setback. Mr. Scardetto said in review of the stormwater plans the township engineer questioned debris left by a former contractor. Mr. Scardetto explained his engineer made an error on the plan and the debris is actually located on his neighbor's property. Mr. Scardetto said another area of concern expressed by the township engineer concerned an underground pipe that he has covered with dirt and lawn; Mr. Scardetto assured the township engineer that the pipe does not transmit any water. Mr. Scardetto questioned the Landscape Review Consultant's inspection of the property, and Mr. Gray responded that is standard procedure when there is a change on a plan and work being done. Mr. Scardetto said the revised plans clarify there is no work being done within the area of concern, Mr. Scardetto was confused about a review of the PennDOT Highway Occupancy Permit that comments on a large tree being located within the sight line of the driveway exit. Mr. Gray said the plan shows a tree and that will be confirmed by an inspection prior to Mr. Scardetto being issued a certificate of occupancy. Mr. Scardetto said it is a dead ash tree. Mr. Scardetto said he realizes his engineer made many errors, but wanted to take this opportunity to clarify them with Mr. Gray and the Board of Supervisors. Mr. Smith wanted to confirm that Mr. Scardetto was aware a stormwater management agreement and escrow will be required per the state mandate, and Mr. Scardetto said he was aware, adding that he is hopeful for plan approval by the end of the year. Mr. Gray encouraged Mr. Scardetto to call him directly in the future when he had concerns rather than reserving all communication between engineers.

Ms. Cozza said she had received a review from the township water and wastewater consultant recommending approval of the Act 537 Planning Module Exemption with the condition that some
