Mr. Scardetto asked the Board to confirm that the existing perimeter fence, which he represented is located inside the right-of-way easement area, will be allowed to remain; that the township will not come and remove it. He said there is 15,000 feet of deer fence used to contain horses, and he wants to install an entrance gate that will be more secure than the existing wooden one. Mr. Gray explained that when the township takes the dedication of the Right-of-Way, the fence will belong to the township, and if work is required in the right-of-way at some point in the future, it would be removed if needed to accommodate the work. Mrs. Rash said if Mr. Scardetto wanted to be assured the fence would not be removed at some point in time, then he should move it out of the right-of-way. Mr. Scardetto said then both of his fence lines are at risk; and Mr. Gray said only if they are in the ultimate right-of-way.

Mr. Scardetto represented there is no trash on the section of right-of-way he is granting to the township, it is on the neighbor's property. Mr. Gray said that during his site review, he will confirm the trash has been removed from Mr. Scardetto's property.

Mr. Scardetto asked for clarification on scheduling of the pre-construction meeting, and Mr. Gray listed the items necessary for completion prior to scheduling the pre-construction meeting, including, but not limited to, Mr. Scardetto signing the documents, the recording of the signed documents, escrows posted, security for improvements, professional escrow, and Mr. Smith's approval of the insurance policy.
