Mr. Calderaio called the meeting to order at 7:30 p.m.

PUBLIC COMMENT

Mr. David Jarret, Grape Bay Drive, was present to elaborate on further developments on his neighbor's property since his discussion with the Board in October and since his written complaint submitted to the township in August. Mr. Jarret presented the Board with a USB containing a video of the Schmalz property taken from his property line. Mr. Jarret claimed that the Schmalz property use has increased in intensity, containing the same hazards, storage trailers, boundless clutter, chaos, junk and fuel containers, presenting the potential for impacting the value of the neighborhood homes. He said there is no fencing and he feels the property lacks safety and security due to the presence of agricultural chemicals.

Mr. Jarret said a new 1000 square foot concrete pad was poured on November 12, 2022 only 15' from his property line, and they installed framing on it today. He claimed there is a new tenant present that is a landscaper.

Mr. Forest asked how long the business has been operating, and Mr. Jarret replied three years; adding that the two original owners died and their son runs a completely different business and does no farming on the property, as the father did.

Ms. Pat Urban, Grape Bay Drive, said she moved into her home in 2019 and said in late summer she saw corn being processed on the Schmalz property, however that operation was taken down and now it appears there are a variety of different businesses being operated. She sees commercial vehicles coming and going and has no idea who the presumed tenants are. Ms. Urban said construction commenced last week on a structure that had been roofed for some time, and now they had poured concrete to create a platform under the existing roofed structure. Mr. Jarret said he had submitted a right-to-know request for permits but had no response. Mrs. Cozza replied the Zoning Officer was investigating the property records.

Ms. Urban was concerned about the presence of hazardous chemicals, and Mr. Smith recommended they call the Environmental Protection Agency (EPA) and the Bucks County Conservation District regarding their environmental concerns as the township has no power to enforce those matters.

Ms. Urban said there is a history of issues: for example in 2019 a house trailer appeared on the property, which she reported to the township. Ms. Urban said the Mr. Schmalz sold the residential portion of the property during the summer and now lives in a camper on the property. Ms. Urban also had concerns about possible well contamination from the debris. Mr. Jarret claimed there is a mulching operation on the property.

Mr. Calderaio said township staff would continue to investigate the property use, and keep Mr. Jarret and Ms. Urban updated.
