## **BUSINESS**

Consideration of recommending Preliminary/Final Approval of the "McIntyre Project", Minor Subdivision plan dated November 20, 2023 as most recently revised May 17, 2024, Township File SA 2024-01, 2 Lots, 3.0 Acres to be conveyed from TMP 6-17-30 to TMP 6-17-29, located in the AG-1 Zoning District, with a 90-day review period expiration date of July 2, 2024.

Mr. John Genovesi and Mr. Cody Spadaccino of Tri-State Engineers & Land Surveyors, Inc. were present, along with property owner Steve McIntyre, to discuss the proposed subdivision plan.

Mr. Genovesi explained that the applicant, Steve McIntyre, proposes to transfer three acres of land in a lot line change between 3152 and 3182 Lower Mountain Road. He explained that the current property line runs vertically from Lower Mountain Road to the back of the properties, and the applicants propose to transfer a 3 acre rectangular piece near Lower Mountain Road from the Dunn's to the McIntyres and use the area as pasture for steer. He said there would be clearing of dead trees and underbrush to turn the area into a pasture, but no other improvements would be necessary.

Mr. Genovesi said that all items in the June 21, 2024 Knight Engineering. Inc. letter are "will comply". Mr. Genovesi said there were several waivers requested which Knight Engineering supported, with the exception of waivers related to stormwater management and the erosion and sediment plan (which were requested due to no planned improvements to be made to the property as part of this application), which were deferred until the time of any future development, Building Permit Application or grubbing activities on the site.

Mr. Gray confirmed that most of the waivers were supported as this is a transfer of land over a 2-stage process, due to the Act 319 status of the Dunn's property. Mr. Gray explained they did not recommend waiving the stormwater and erosion and sediment plan requirements in case there were improvements built in the future but did recommend deferring them.

Mr. Gray said the Zoning Officer had confirmed the application shows an appropriate use for the site.

Mr. Rosanova of the Bucks County Planning Commission said their only review comment was regarding the proposed use. He questioned how many steers and confirmation of the principal use and explained that they were told at the Buckingham Township Planning Commission meeting that there would only be a handful of steers and the principal use is the existing home, so he had no additional comments.

Ms. Manicone, Landscape Review Consultant, confirmed she had visited the site with Mr. Spadacino and discussed a sizeable area of dead ash trees to be removed, and a couple of large caliper trees to be protected. She said the applicant had addressed all of her comments in their revised submission, including planning to add decorative fencing to protect tree trunks from cattle nibbling on them. She said it is a lovely site.
