Mr. Gray explained this is the second to last lot in Stoneymead to be developed, with the other one under construction. He said that site distance issues need to be resolved, and the matter should be completed and closed out very soon. Mr. Bussinger was present and expressed his disappointment that an extension was required, and his final escrow release would not happen until the site distance and tree issue was resolved. He saw no reason why the two were connected. Mr. Smith advised that an easement is required for the area that Mr. Bussinger planted trees in the Township owned Right-of-Way, and that Mr. Bussinger's attorney had provided the draft easement earlier today. However it cannot be added to the agenda per legalities with updating the agenda within 24 hours of the meeting. Mr. Smith said the matter will be scheduled on the Board of Supervisor's January 6th meeting agenda for conclusion.
