### Holicong Park meadow creation update—Jim Walter and Owen Zalme

- Due to delays in approving the state budget by the legislature in Harrisburg funding for the project is not available to begin this fall and is delayed to Spring 2026
- Communications: Andrea Strout submitted an article to the Bucks
  County Herald about conversion of lawns to meadows and its
  benefits. Website will be updated with guidance on how an
  individual can develop a wildflower meadow on their property.
  Buckingham and the Conservation District will schedule a Town Hall
  public information roundtable event

#### **Update Buckingham Tree List**

- Buckingham is pursuing updating the 2009 municipal planting and tree list. The list is currently divided by street trees, community subdivision trees, perennials, etc. Native plants will be emphasized.
- Jim Walter is still waiting to hear from the State Forestor for guidance on appropriate trees

### Next Steps:

- Buckingham will apply for an Arbor Day Foundation Tree City USA designation
- Jim Walter has consulted with PA State Forester, local nurseries, master gardeners, sensory garden workers, and residents for input on tree list.
- Residents have reacted with enthusiasm to our request for information on their trees within the Township of exceptional natural and historic value. Brittany Clark is receiving and collating the information.

# **Tax Building Planting Project**

- Jim Walter, Diane Smith and two Master Gardeners met at the tax building on the corner of Rt 413 and Hughesian Drive to review the site and make recommendations for native plants and their location
- **Next Steps:** When a plan is developed, present to Bucks Beautiful and Township to identify funding sources, a construction schedule for as early as Fall 2025 as well as volunteer list to perform

construction. We will request sod cutting and compost from the township maintenance folks when the project is ready to begin
