Mrs. Cozza explained that CivicPlus will provide a new website for the township, very user friendly and ADA compliant to meet new requirements coming in the next few years. She said it will take a good 6 months to get it up and running. Mr. Forest explained that NextRequest will help simplify the right-to-know burden for staff. Mrs. Cozza explained that the township has a tracking system that we've developed, but the volume is so high that we need something more professional as we receive many requests every day. She said it would be very helpful if our state representatives updated the right-to- know law as requests come from all across the country and are starting to come from AI requesting volumes of information.

Mr. Gray explained the Route 313 Corridor (Swamp Road) Green Light Go Project was proposed in 2018-2019 by Doylestown Township to synchronize traffic lights through the Cross Keys area, from the bypass almost to Route 202. He said the project includes Doylestown Township, Doylestown Borough, Buckingham and Plumstead Townships. Mr. Gray said the original

estimates in 2021 had a projected cost of about \$10,000, and in 2024 when the project was bid prices were 15% higher, and PennDOT had reduced their match from 80% to 70%. Mr. Gray said over the last year with contractors making improvements to intersections and lights, and the processing of 3 change orders without Buckingham's approval, the townships' responsibility was increased to \$29,000+. Mr. Gray said that while the cost was not necessarily processed the correct way, the project results are beneficial to Buckingham Township and he supports the payment.
